In addition, through conducting a total assessment at the planning stage of business projects, we seek to reduce the possible risks on human health and environment.



# 5. Safe and Healthy Work Environment



## Preface

We take an active role in disaster prevention, secure safety and promote a healthy environment through all the stages of our business activities (such as R&D, procurement, manufacturing, distribution, sales, etc.).

### How to Behave

- (1) Disaster prevention
  - i. We establish safer working environment through conducting daily disaster prevention activity and reviewing daily operation in order to minimize damages of disaster to surrounded neighbors and effects toward users of our services.
  - ii. We implement emergency response procedures quickly to limit the spread of damage. This will be done by following the emergency response manual reporting procedures, investigating the root-cause and disclosing required information in a timely fashion.
- (2) Labor safety and health
  - i. We acknowledge that eliminating labor accidents are the responsibility toward society. We continue to strive creating safe working environment to prevent such labor accidents.
  - ii. We review the working conditions to limit long working hours and to improve mental health and working environment.


#### Notes

### Preface

We build business operations that are resilient to sudden accidents/incidents such as natural disasters.

#### How to Behave

#### (1) Basis of action

We protect ourselves and own family members' safety first when significant incidents or natural disasters occur. Once it is secured, we switch to take care the workplace and society where we belong to.

(2) Formulation of emergency response plans

We formulate emergency response plans by identifying predictable risks of our daily business operations (in areas such as procurement, manufacturing, logistics, business activities, etc.) and determine in advance how to maintain business continuity in case of emergency. Also, it is important to secure alternative methods in advance as there could be some limitation when emergencies occur.

(3) Emergency response training

We conduct regular training to ensure smooth action of collecting emergency related information and activate emergency response plan when it is necessary.



### Preface

### How to Behave

- (1) We ensure the safety and quality of our products and services in all our processes from R&D to manufacturing/ processing, distribution/sales, and disposal. Most of all, we put the highest priority on safety.
- (2) We fulfill safety and quality assessments of our products and services based on "Teijin Group Regulations for Group PL and Quality Assurance", and provide products and services that are well received by the society. We also review safety and quality of legacy products and services in the market if necessary.
- (3) We report complaints and incidents regarding products and services to supervisors and the Product Liability/Quality Assurance lead of each business group following our reporting criteria.
- (4) We comply with PL laws (Product Liability Law) and any laws and regulations related to products and services globally. In addition, we comply with the articles stipulated in the signed contracts with customers.
